ANNUAL GENERAL MEETING 2008

Held at Home Guard Social Club on 22rd May 2008

The meeting commenced at 20.10, once the requisite number (14) of members were present. The meeting opened with the Chair, Paul Reid, outlining the short agenda:

- 1. Chairman's Annual Report
- 2. Ratification of new Board members in the absence of challenging candidates
- 3. Trust Accounts for the Financial Year ending 30th November 2007 and Accountant's Independent Examination Report
- 4. Appointment of Accountant for Financial Year ending 30th November 2008
- 5. Any Other Business
- 1. Our Chair, Paul Reid presented his Report, a copy of which is enclosed.
- 2. Adrian Williamson, as Secretary, explained that there were two members who had put themselves forward to stand for election to the Trust Board and there were currently five vacancies. The Society rules allow for a maximum of 12 elected members with 4 further vacancies for co-opted members during the year. Following the last AGM there were 9 elected members and two further members were co-opted to the Board. During the year, 2 of the elected members chose to step down from the Board. None of the elected members are required to stand down this year, however, both co-opted members stood down as required before the AGM. Both members co-opted to the Board during the year are standing for election. Campbell Smith and Graham Page were unanimously ratified to join the Trust Board.
- 3. Campbell Smith, as Treasurer, gave an explanation of the Independent Examination Report that had been distributed. These Accounts had been prepared by Hargreaves & Woods, who the Board appointed following last year's AGM, at which members voted in favour of a change to the Society rules to allow an Independent Examination to be carried out in accordance with the Supporters Direct membership, rather than a full audit which had been carried out previously.

It was highlighted that the Independent Examination Report actually contained more information than previous audited accounts for less than half of the cost!

A copy of the Report is available to any Trust member on written request.

A number of questions from members were answered during the course of this item:

- a breakdown of the "Events & Fanzine" income was confirmed as being £800 for the Race Night held in July 2007 and £1200 being the sales of two issues of the fanzine.
- a question was asked about the lottery and it was confirmed that this was run by the football club and was nothing to do with the Trust.
- a comment was made about the Trust shareholding not being reflected in the accounts yet the loan notes are. Campbell confirmed that there is no value to the shares owned by the Trust and as such were not shown in the accounts. The Trust shareholding remains unchanged at 426,361 representing 2.11% stake in the club and for which the Trust had paid £8600. The accounts were accepted by members present as being accurate and fit for submission to the Financial Services Authority.
- **4.** Due to the excellent quality and value provided by Messrs Hargreaves & Woods of Chester it was the Board's recommendation to re-appoint them. All members voted in favour of the Board's recommendation.

There was no further business but a number of topics were then discussed in an open question and answer session at the end of the meeting.

However, the advent of real-time coverage via outlets such as Sky Sports News and BBC's Score, has seen a progressive downturn in the number of people subscribed to DevaTXT.

It has reached such a point that the minimum payment threshold set by the platform provider is not reached on a regular basis, rendering the service as not viable.

The Trust would like to thank Campbell for all his work on DevaTXT over the years and, of course, all of the users of the service in the past

As shareholders in the business, a number of pertinent questions were listed for asking of the CCFC Board of Directors, on behalf of the Trust members.

Unfortunately, the first question by Paul Reid, Trust Chair, was also the last as it was met with a straight-forward reply of "It's none of your business!" by the club owner.

The question was, quite simply, who are the debtors and creditors of the club? Unfortunately, we still do not have the answer.

As this was the first AGM held by the club since 1991, the Trust believed it could have opened up avenues for communication and transparency – unfortunately it was not to be. The Board hope that any future AGMs will prove more positive than this last one.

Quite inaccurate press coverage followed our withdrawal. However, our reason for standing down was quite simply that if something isn't broken then why fix it, something missed by the club.


For the record, no one ever refused the club access to the site as was reported at the time, indeed we gave 4 weeks notice to allow them to prepare themselves.
